### **POSITION SUMMARY**

Provide direct primary care at Hidalgo Medical Services under contract with Hidalgo Medical Services (HMS) a non-profit, state-supported primary care clinic.

The delivery of quality service and positive interaction with our customers is critical to the completion of all the tasks within this job description, thus the employee is responsible for establishing and maintaining interpersonal relationships with patients, visitors, and HMS employees in a courteous, respectful and professional manner. Guidelines include all HMS policies and procedures.

## POSITION ACCOUNTABILITIES

- 1. Provide clinical leadership in clinic operation.
- 2. Supervise and teach medical students, other health sciences center students and residents in patient care and community health.
- 3. Administer clinical aspects of HMS services/work with community agencies and other provider groups in developing integrated service delivery system in Southwest New Mexico.
- 4. Supervise and work with HMS Physician Assistants and Nurse Practitioners and clinical support staff.
- 5. Providers may visit patients in their home, as necessary for pediatric care purposes.
- 6. Supervise and teach medical students, other health sciences center students and residents in patient care and community health.
- 7. The position of Pediatric Physician requires compliance with Hidalgo Medical Services written standards, including its Compliance Program and Standards of Conduct and policies and procedures. Such compliance will be an element considered as part of the regular performance evaluation.
- 8. Failure to comply with Hidalgo Medical Services Written Standards, which may include the failure to report any conduct or event that potentially violates legal or compliance requirements or Hidalgo Medical Services Written Standards, will be met by the enforcement of disciplinary action, up to and including possible termination of employment, in accordance with Hidalgo Medical Services Compliance Program Policy and Procedure.
- 9. Supervise and teach medical students, other health sciences center students and residents in patient care and community health.
